RE: Multilateral Treaty named: **Comprehensive Claim February 11, 2009** as filed to all 'parties' inclusive of the United Nations at that time and as acknowledged and taken up (November 2014) by Prime Minister Steven Harper pursuant to 'instructions, directions and promises' made historically (Documents of Marque) and contemporarily by the Acting Head of State; His Royal Highness Prince Charles to our un-ceded historic matriarchal Indigenous/Aboriginal Nation/State.

INTENTION: To identify clearly the intention of OUR un-ceded matriarchal Indigenous Nation/State to not be placed as a 'PARTY' to TREASON and International Fraud. As a separate matriarchal Indigenous/Aboriginal Nation/State we will NOT SURRENDER to the foreign culture who occupies our Traditional Lands in willfull trespass, religious racist and sexist demands as placed onto our Nation/State in breach of 'obligation' in conduct of bad faith breach of trust, and abusive criminal negligence by the Vichy Regime (AANDC) and it's unelected administrative regime.

THAT: on the DIRECT REFUSAL under claim of 'being to busy' Minister B. Valcourt refused the DUTY as placed on to him under 'simple signature' by Prime Minister Steven Harper to 'schedule meetings' with our un-ceded matriarchal Indigenous/Aboriginal Nation/State on behalf of the Head of State and Head of Government pursuant to 'obligation' under Section 3 of U.N. Treaty Handbook to the **Treaty Named; Comprehensive Claim February 11, 2009** and FAILED to notify either Prime Minister Steven Harper or Her Majesty Queen Elizabeth II as to the 'planned' abrogation of DUTY based solely on refusal to provide same rights to services to an Indigenous un-ceded Matriarchial Nation/State.

THAT: Minister Valcourt directly tasked under 'simple signature' by the Head of the Colonial Trade Corporation, Prime Minister Steven Harper has by intentions and omissions placed the Head of State Her Majesty Queen Elizabeth II and the Head of Government Prime Minister Steven Harper in dishonor, bad faith and breach of trust pursuant to U.N. Charter and all signatures thereafter.

That: In breach of Privateer License and Documents of Marque (Royal Proclamation 1763, British North American Act 1867, Constitution of Canada 1982) and Domestic and International Human Rights and alleged Rights under the Canadian Charter of Rights and Freedoms (Section 1, 7,15 & 25) in abrogation of Indigenous/Aboriginal and Nation/State Rights (State Immunity Act 1984, Millennium Declaration 2000, article 102 of the Charter) the direct circumvention of the Minister of Foreign Affairs pursuant to 'obligation' under U.N. multilateral Treaty Process by the Office of the Prime Minister on behalf of Prime Minister Steven Harper as one of (3) three identified 'persons'

with the 'authority' to enter into, ratify, agree or dismiss multilateral treaties pursuant to the U.N. Treaty Handbook.

Prime Minister Steven Harper in conduct circumvented the elected Minister of Foreign Affairs and in abrogation and contempt of Rule of Law and Supreme Court Rulings and signature to the U.N. Charter by intentions and omissions has refused 'same rights to services' to our Indigenous/Aboriginal Nation/State to continue the long term support, maintenance of 'original' intentions as placed into current Trade Colony 'policies' pursuant to the demand that as Indigenous/Aboriginal 'individuals, group and society' we must be 'racially cleansed' by the foreign Vichy Regime and surrender to their 'beliefs' that remove Indigenous individual, group and society 'self-identity' as a separate Aboriginal culture (Section 35(2) Constitution).

THAT: the intention and omission of conduct and actions by the unelected Vichy Regime to bring to fruition the planned long term Indigenous/Aboriginal genocide of one of the three recognized separate Indigenous cultures and the largest oldest Nation/States and it's people through 'policies' in continuation of historic religious racist sexism to FORCE 'enfranchisement' is we believe conduct of Rude Unjust War.

That: by intention and omission in abrogation and derogation of the U.N. Charter and Vienna Convention as placed into 'instructions' under the U.N. Treaty Handbook under 'simple signature' Prime Minister Steven Harper 'appointed' a person without 'authority' or jurisdiction to enter into a multilateral Treaty Process and Minister B. Valcourt (AANDC) an elected official and appointed Head of the Crowns Vichy Regime (Aboriginal Affairs and Northern Development) by omission has in bad faith and breach of trust failed to fulfill the single DUTY placed onto him to protect the 'interests' of the Queen's 'class of subjects' who elected him and by intention in continuation of conduct of religious, racist sexism brought as a dis-ease to Traditional Lands has Dishonored the 'PROMISES and disobeyed the INSTRUCTIONS' made historically by the previous hereditary leaders of Great Britain and contemporarily by Her Majesty Queen Elizabeth II and Her representative His Highness Prince Charles.
